JOB PROFILE

THIS ASSIGNMENT PROVIDES TRAVELING ROAD SWITCHER ON AMTRAK'S MAIN LINE BETWEEN BAYVIEW SOUTH END AND MINNICK ON THE PORT ROAD SECONDARY TRACK, AND ALSO TO PRINCE ON AMTRAK MAIN LINE TO ENTER AMTRAK'S PERRYVILLE M&W BASE. WPBV20 OPERATES FROM BAYVIEW SOUTH END TO OLD LINE ON MONDAY - WEDNESDAY - FRIDAY. ON TUESDAY AND THURSDAY, CREW WILL SERVICE TILLEY CHEMICAL, AND BGE POWER PLANT AT CHASE, MARYLAND; ABERDEEN MILITARY BASE AND CLOROX PLANT AT PERRYMAN, MARYLAND AS NEEDED.

NOTE: YOU MUST HAVE AN ENGINE ON EACH END OF TRAIN WHEN DEPARTING YARD.

1. TILLEY CHEMICAL - MIDDLE RIVER, MD. MP 85 ON AMTRAK MAIN-LINE

ZTS 769. FIVE (5) CARS MAX. D=YES, ON TRACK 225 LEAD, WILL HOLD FOUR (4) CARS TO DERAIL.

NOTE: CONDUCTOR MUST STOP AT SECURITY OFFICE AFTER GATE IS OPENED TO REGISTER CREW IN AND TO SECURE KEY TO TILLEY'S GATE AND ALSO VISITOR'S BADGE.

2. BGE-CHASE, MD.

ZTS 759 D=YES. SECURITY GUARD ON DUTY WILL OPEN GATES AT CAROL ISLAND ROAD TO LET CREW IN TO YARD LOADED COAL TRAIN ON TRACKS 753-752 AND 751. TRACK 757 IS A RUN AROUND TRACK WHERE ENGINES ARE STORED. EMPTY OUT BOUND TRAIN IS PULLED FROM TRACKS 761-762-763.

TRACK CAPACITY 753 IS APPROX. 38 CARS.

TRACK CAPACITY 752 IS APPROX. 35 CARS.

TRACK CAPACITY 756 IS APPROX. 25 CARS.

NOTE: YOU MUST REMOVE GROUND LINES FROM REAR END OF TRACKS 761-762-763 PRIOR TO PULLING TO DOUBLE UP TRAIN. TRACK 754 IS LOCATION FOR DANGEROUS TANKS. DERAIL ON THIS TRACK.

3. DEPT. OF DEFENSE, ABERDEEN, MD.

ZTS 733 20 CARS D=NO

PLACE AND RECEIVE CARS FROM THIS LOCATION ON TRACKS 733 AND 734. FLAT CARS TO BE UNLOADED MUST BE SHOVED BACK BEYOND GATE ON OUTSIDE TRACK TO THE RIGHT TO UNLOADING RAMP.

NOTE: NO SECURITY GUARD ON DUTY AT THIS LOCATION, CONRAIL LOCK ON GATE.

4. CONSTAR - PLANT A - HAVRE DE GRACE MD

ZTS 718 12 CARS D=NO. SEE EMPLOYEE ON DUTY FOR CARS TO BE SPOTTED AND EMPTIES TO BE PULLED FROM TRACK 718. EXCESS LOADS ARE STORED ON TRACK 726.

5. CONSTAR - PLANT B - HAVRE DE GRACE MD

NO CARS ARE PRESENTLY BEING ORDERED TO B. PLANT.

6. TANNER INDUSTRIES - HAVRE DE GRACE MD

ZTS 718 12 CARS D=NO.

CUSTOMER IS A SUPPLIER OF AMMONIA PRODUCTS. SEE EMPLOYEE ON DUTY OR LOOK FOR INSTRUCTIONS ON GATE IF NO ONE IS THERE. CONRAIL LOCK ON GATE. PLACE EXCESS CARS ON TRACK 721. LOOK FOR SKATES ON ALL CARS AT THIS LOCATION.

7. J. M. HUBER - HAVRE DE GRACE MD

ZTS 728 10 CARS D=NO.

CONDUCTOR MUST CHECK BOX FOR OUT BOUNDS AT TRACK 728 IN ADDITION TO CARS ON 1580. SEE PERSON IN CHARGE IF INSTRUCTIONS ARE NOT CLEAR. YOU MUST UNLOCK GATE TO ENTER AND CLOSE AND LOCK GATE WHEN DEPARTING.

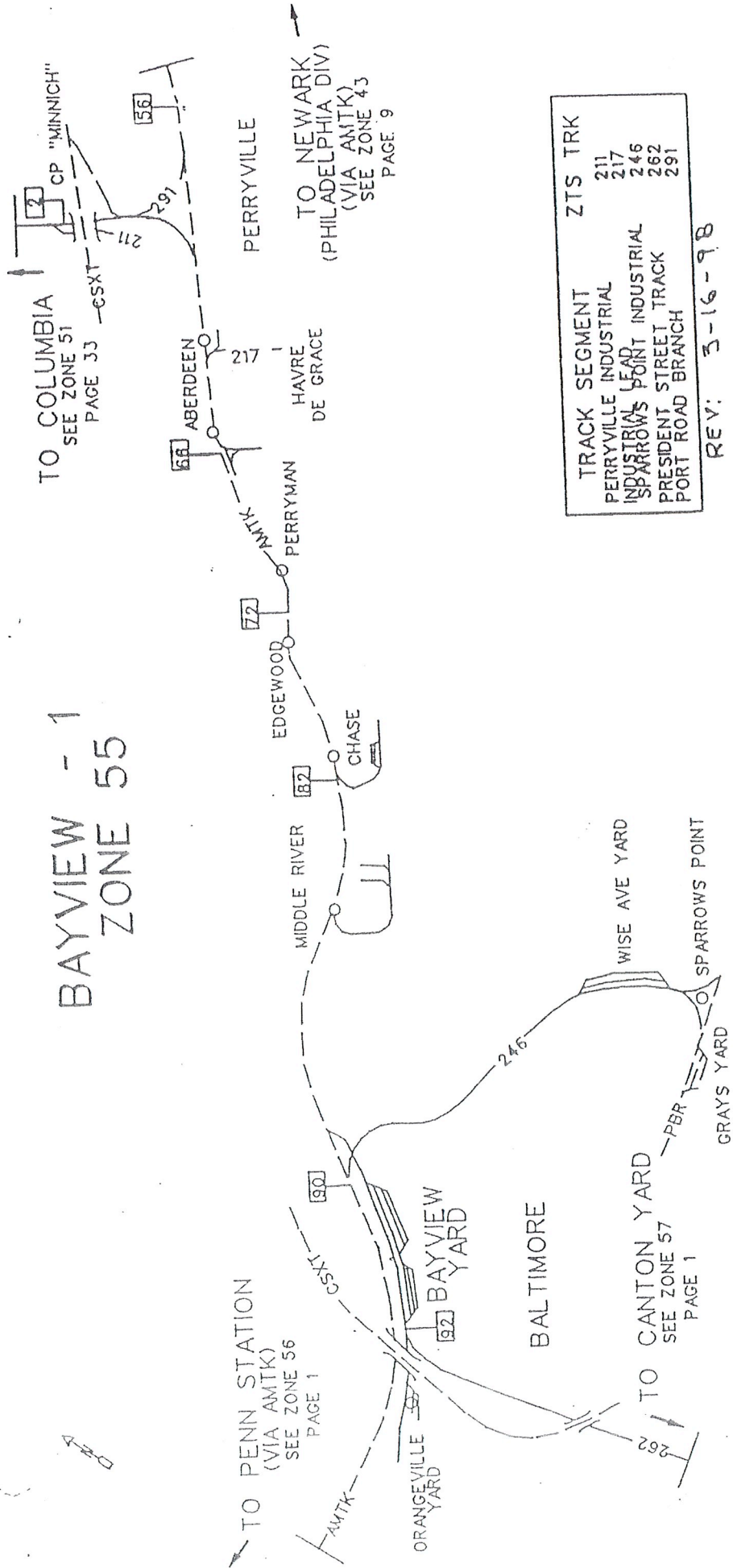
NOTE: YOU MUST SPOT TANK CAR ON TRACK 730. HUBER EMPLOYEES WILL OPERATE CROSSING GATES, SHOVE TANK CAR ACROSS STREET, APPLY HAND BRAKE, CUT LOOSE FROM CAR, LAP KNUCKLES AND SHOVE TO SPOT. YOU CANNOT MAKE A CUT ON THIS CAR ON CURVE.

8. CLOROX - PERRYMAN, MD

ZTS 741-743-747 D=NO

BOX CARS ARE TO BE SPOTTED ON TRACK 741, DOORS 1 THRU 4. AS A RULE, CARS ARE USUALLY SPOTTED AT DOORS 3 AND 4 UNDER THE ROOF. ONLY TWO (2) CARS CAN BE SPOTTED FOR UNLOADING ON BOTH TRACKS 743 AND 747, TWO PER TRACK. ON TRACK 747 YOU MUST LEAVE ROOM FOR TRUCKS TO UNLOAD; YOU CAN LEAVE ONE CAR ON 747 TO CLEAR ROAD.

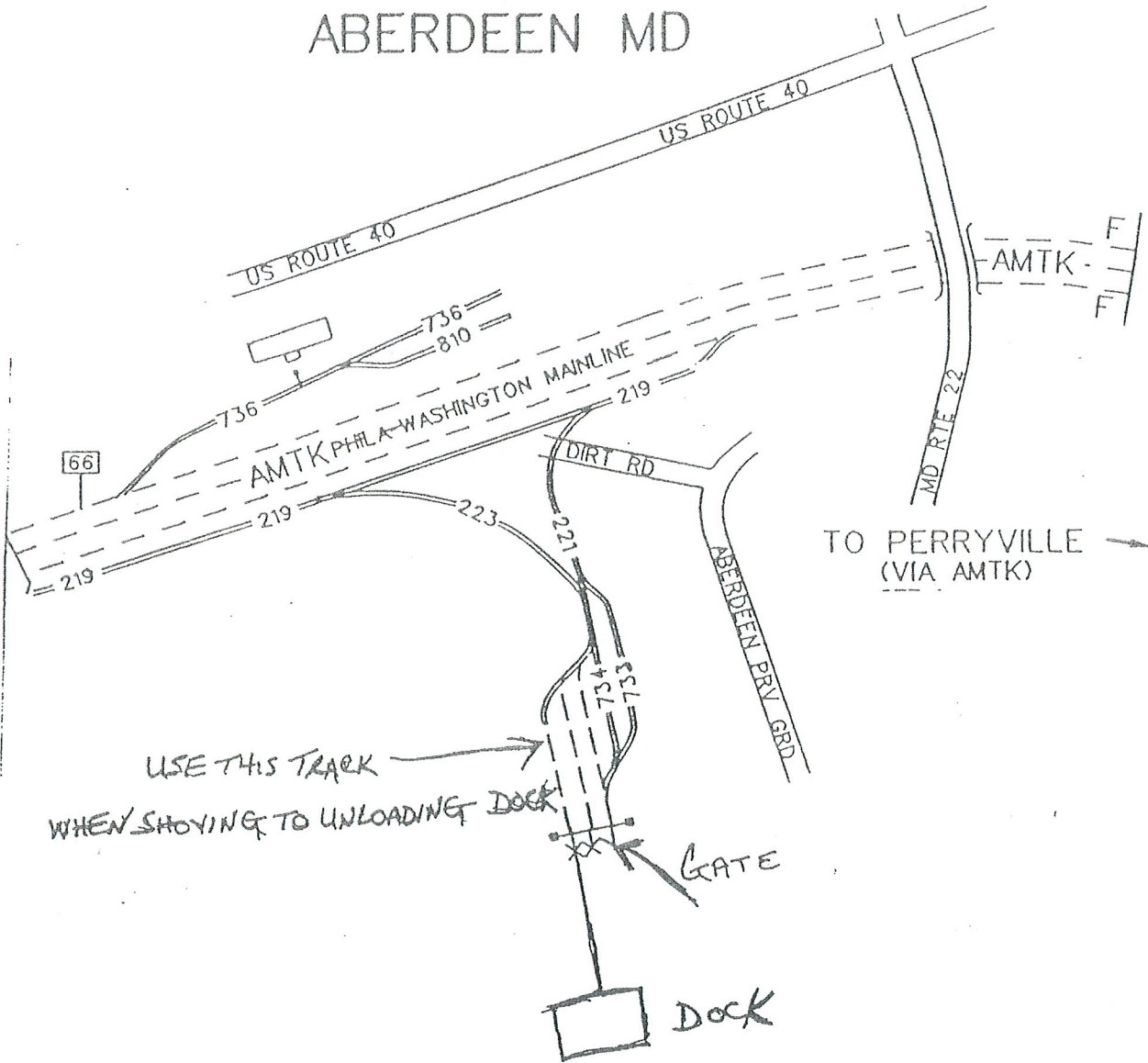
